# Profile of Speakers

## Inaugural Session

### **Professor Sachin Kumar Sharma**

Director General, RIS



Prof. Sachin Kumar Sharma is the Director General of RIS. He has over two decades of expertise in international trade, development cooperation, and multilateral and regional negotiations. His research, advocacy, and capacity-building work have shaped discussions on trade and development, agricultural subsidies, investment, food security, sustainability, market access, trade disputes, transparency, LDC graduation, Aid for Trade, and negotiations at the WTO, FAO, G20, and in regional trade agreements. He holds an M.Phil and a PhD in Economics from Jawaharlal Nehru University (JNU), Delhi, with a specialisation in the WTO, international trade, quantitative techniques, and agricultural policy. He is skilled in econometrics, Computable General Equilibrium (GTAP), Partial Equilibrium Modelling, and statistical tools, with extensive experience in trade analytics. Prof. Sharma has authored six books, numerous peer-reviewed journal articles, several working papers, and book chapters, in addition to regularly contributing to policy debates through articles in leading newspapers and participating in global forums. Before joining RIS, he served as a Professor at the Centre for WTO Studies (CWS) at the Indian Institute of Foreign Trade.

### **Ambassador Sumith Nakandala**

Former Secretary General, BIMSTEC & Chairman, BoBED, Colombo



Ambassador Sumith Nakandala is a career member of the Sri Lanka Foreign Service with extensive experience in diplomacy and international relations. He has served at the Ministry of Foreign Affairs in Colombo and in overseas postings in the Maldives, India (New Delhi and Chennai), and the United States (New York). He has held ambassadorial appointments to Nepal, Iraq, and the Netherlands, and served as Deputy High Commissioner in Chennai and London. From 2014 to 2017, he was the first Secretary-General of BIMSTEC. He later served as Additional Secretary at the Ministry of Foreign Affairs and as Sri Lanka's Ambassador to the Netherlands, with concurrent accreditation to the OPCW and the Common Fund for Commodities. He is currently a Visiting Scholar at the Department of Political Science, University of Peradeniya, Colombo.



## **Ms. Mikiko Tanaka**

Director and Head of ESCAP Sub-regional Office for South and South-West Asia Office, New Delhi

Ms. Mikiko Tanaka is the Director and Head of ESCAP Sub-regional Office for South and South-West Asia Office, New Delhi effective 2 May 2022. Ms. Tanaka brings over twenty-five years of experience within the United Nations system. She most recently served as the United Nations Resident Coordinator in Guyana and worked with UNDP in Guyana, Yemen, Timor-Leste, Pakistan, Benin, China, Lao PDR and New York. Prior to the UN, she worked for Care International in Thailand and the financial sector in Japan. Ms. Tanaka holds master's degrees in applied conflict transformation from Paññasastra University and Center for Peace and Conflict Studies in Cambodia, public policy and management from the University of London and in rural development management from Khon Kaen University in Thailand, and a bachelor's degree from the International Christian University in Japan.



## **H.E. Indra Mani Pandey**

Secretary General, BIMSTEC

His Excellency Indra Mani Pandey is a career diplomat of India. He joined the Indian Foreign Service in 1990. Before his current assignment, he served as Permanent Representative of India to the United Nations and Other International organizations in Geneva. He had earlier served as Additional Secretary in the Ministry of External Affairs in-charge of Disarmament & International Security Affairs Division. During his 33 years long career as an Indian diplomat, Ambassador Pandey has served as Ambassador of India to the Sultanate of Oman. Before his Ambassadorial assignment in Muscat, he served as Deputy Ambassador of India to France and Consul General of India at Guangzhou, China. Ambassador Pandey had also served in various diplomatic capacities at Indian Missions in Cairo (Egypt), Damascus (Syria), Islamabad (Pakistan), Kabul (Afghanistan) and Permanent Mission of India to the Conference on Disarmament, Geneva (Switzerland). During his earlier stints at the Ministry of External Affairs of India in New Delhi, Ambassador Pandey handled assignments in West Asia and North Africa Division; Consular, Passport and Visa Division; Counter Terrorism Cell; Americas Division; and Bangladesh, Sri Lanka, Maldives and Myanmar (BSM) Division. During October 1998- June 1999, Ambassador Pandey attended Foreign Service Programme at Oxford University, the U.K. In 2009, he attended the 49th Annual Course on National Security and Strategy, conducted by National Defence College of India.



## Ambassador Periasamy Kumaran

Secretary (East), Ministry of External Affairs (MEA), New Delhi

Ambassador Periasamy Kumaran belongs to the 1992 batch of the Indian Foreign Service. His first assignment was as Third Secretary in the Embassy of India, Cairo (1994-1997), followed by his posting as Second Secretary in the Embassy of India, Tripoli (1997-2000) and then as First Secretary in the Embassy of India, Brussels (2000-2003). Following this, he returned to India and served as Deputy Secretary [Europe West] in the Ministry of External Affairs (2003-2005). Amb Kumaran then served as the Regional Passport Officer, Bangalore (2005-2007), followed by a posting to Pakistan, where he served as Counsellor in the High Commission of India, Islamabad (2007-2009) and then as Counsellor in the Embassy of India, Washington, (2009-2011), and thereafter as Deputy High Commissioner at the High Commission of India in Colombo (2011-2014). His next assignment was at the Ministry of External Affairs, New Delhi, as Joint Secretary (Consular, Passport & Visa Division) (2014-2016). He then moved to Qatar for his first Ambassadorial assignment, to serve as Ambassador of India, Doha (2016-2020). From Doha, he moved to Singapore as the High Commissioner of India to Singapore (2020-2023). In July 2023, he assumed charge as Additional Secretary (Economic Relations & Development Partnership Administration) and was later promoted to Special Secretary (ER & DPA) in the Ministry of External Affairs, New Delhi. He took over his current charge as Secretary (East) on 1st April 2025. Shri Kumaran has a B.Tech in Electronics and Communication, from IIT Madras (Chennai).

## Mr. Jayant Dasgupta

Former Indian Ambassador to WTO and Member, RIS Governing Board, New Delhi

Mr. Jayant Dasgupta is member of the Indian Administrative Service, and a trade specialist with extensive experience in multilateral and bilateral negotiations. Served as India's Ambassador to the WTO (2010-2014), he helped shaping national positions on agriculture, services, and intellectual property during the Doha Round and other key negotiations. He held senior roles across the Commerce Department, Ministry of Textiles, and as Secretary to the Prime Minister's Economic Advisory Council, and contributed to policies on FTAs, SEZs, and TRIPS. He has been recognized for advocacy on protecting India's agriculture and dairy sectors, advancing interests of labour-intensive industries such as textiles and leather, and navigating complex India-US trade dynamics. He serves as an arbitrator in trade disputes and a frequent commentator on multilateralism versus bilateralism. He combines technical legal knowledge with practical negotiation experience to advise governments, industry stakeholders, and international forums on trade strategy, dispute resolution, and policy design that balance development objectives with global trade commitments.



## Prof. Ram Singh

Director, Delhi School of Economics (DSE), Delhi University and Member of the RBI Monetary Policy Committee

Dr. Ram Singh is Professor at the Delhi School of Economics (DSE), University of Delhi. He holds Ph.D. (JNU, New Delhi) and Post-Doctorate (Harvard) degrees in economics. His areas of research interests are contract theory, public economics, public private partnerships, and law and economics. He is a recipient of Fulbright, Commonwealth, and Erasmus Mundus Fellowships in economics Ronald Coase Fellowships in economics. Some of his publications include "The Inefficiency of Compulsory Land Acquisition" in the Economic and Political Weekly, 2012; "The Efficiency of Comparative Causation" (with Francesco Parisi) in the Review of Law and Economics 2011; "Delays and Cost Overruns in Infrastructure Projects: Extents, Causes and Remedies" in the Economic and Political Weekly, 2010; "Comparative Vigilance" (with Allan Feldman), in the American Law and Economics Review, 2009. He has taught at the DSE, Brown University, University of Hamburg, Jawaharlal Nehru University, and has been Commonwealth Fellow at the London School of Economics. He is Co-editor of the Indian Economic Review.



## Dr. Wimon Punkong

Deputy Executive Director (Academic), International Institute for Trade and Development (ITD), Bangkok

Dr. Wimon Punkong serves as Deputy Executive Director (Academic Affairs) at the International Institute for Trade and Development (ITD) under the Ministry of Commerce, Thailand. He is a researcher specializing in international trade economics, with more than 25 years of experience in policy-oriented research. His research focuses on trade facilitation, impact analysis of trade agreements at both bilateral and multilateral levels, enhancing the utilization of trade agreements, the transition to a green economy and a digital economy, and the promotion of international investment to support supply chain development. He plays an active role in academic communication and knowledge dissemination, providing expertise to entrepreneurs and students as an international trade specialist, with the aim of raising awareness of international economic issues and their implications for economic and social development.



## Professor Mustafizur Rahman

Distinguished Fellow, Centre for Policy Dialogue (CPD), Dhaka

Professor Mustafizur Rahman is a Distinguished Fellow at the Centre for Policy Dialogue (CPD), Dhaka. Earlier Professor Rahman had taught at the University of Dhaka. Dr. Rahman was educated at Moscow State University, where he did his Ph.D., Oxford University, UK and Warwick University, UK, where he was Post-Doctoral Fellow and Yale University, USA, where he was Senior Fulbright

Fellow. His recent works have focused on Bangladesh's macro-trade-fiscal policies, sustainable LDC graduation and regional and global integration. His works were published by Routledge, McMillan, Hart and other reputed publishing houses. He was a member of Panel of Economists of various Five-Year Plans of Bangladesh. He is a Series Editor of South Asia Economic Policy Studies published by Springer. He was a member of the White Paper Committee set up by the Interim Government of Bangladesh and is currently a member of the High-Level Expert Group set up to advise the Government on Bangladesh's upcoming LDC graduation.

### **Dr. Dayaratna Silva**



**Former Ambassador of Sri Lanka to WTO and Executive Director of Pathfinder Foundation, Colombo**

Dr. Dayaratna Silva is an International Trade Economist with over 35 years of experience specializing in trade and economic policy, trade facilitation, and international economic and development policy. He holds a Bachelor of Commerce (Hons.), First Class, from the University of Peradeniya, a PhD in Economics from the University of Melbourne, and a master's degree in international economics from the University of London. He currently serves as Executive Director of the Pathfinder Foundation and has previously held senior roles with the International Trade Centre in Geneva and UNESCAP in New Delhi. His diplomatic and public service career includes appointments as Sri Lanka's Ambassador and Permanent Representative to the WTO, Director of Commerce at the Department of Commerce (DoC) in Sri Lanka, Consul General to the UAE, and Minister (Economic and Commercial) in Geneva, Brussels, and London. During his career, attached to DoC spanning over 25 years, he was responsible for a wide range of duties, including representing and safeguarding Sri Lanka's interests in multilateral and regional trade negotiations under the WTO, UNCTAD, GSP, GSTP, SAARC, and BIMSTEC frameworks.

### **Mr. Atul Kaushik**



**Former Additional Secretary, Government of India and GDC Fellow, RIS, New Delhi**

Mr. Atul Kaushik has worked in the Government of India for 35 years dealing with bilateral and multilateral trade policy, climate change, justice, and the Parliament. He has been India's negotiator for international trade at the WTO and climate change at the UNFCCC. He has delivered multiple development cooperation projects in Africa and for developing country Missions in Geneva. After retirement, he has been working on development cooperation including triangular cooperation with Indian, U.S., and German governments. Currently, he advises Research and Information System for Developing Countries (RIS) on India's development partnership initiative called DAKSHIN - the Global South Centre of Excellence, leads its Global Development Centre (GDC) and contributes to its international trade law related work.

### **Dr. Rajan Sudesh Ratna**

**Dy. Head and Senior Economic Affairs Officer, UNESCAP-SSWA, New Delhi**

Dr. Rajan Sudesh Ratna is a policy specialist with 39 years of experience in formulating government trade and economic policy, leading research, and delivering technical assistance to governments. Former Indian civil servant with 25 years in the Ministry of Commerce, Government of India, he was responsible for India's foreign trade policy and trade negotiations at the WTO and in bilateral/multilateral FTAs. Implemented Uruguay Round commitments and led India's engagement in the Doha Round. He has served as lead negotiator on 15+ Free Trade Agreements (1999–2012). He was Professor and Head, Centre for WTO Studies, Indian Institute of Foreign Trade (2008–2010); visiting professor at universities in India and abroad. He has been prolific author of books and peer-reviewed articles; recent UNESCAP paper on reciprocal tariffs and their impact on South and South-West Asia. He has been recognized for strategic negotiation skills, policy design, capacity building, and bridging research with practical policy implementation. Dr. Rajan holds Ph.D. in Economics; M.Phil in Environmental Sciences; Executive Programme in Trade Policy and Negotiations, Harvard University.



### **Dr. Rupa Chanda**

**Director, Trade, Investment, and Innovation Division, UNESCAP, Bangkok**

Dr. Rupa Chanda is the Director of Trade, Investment, and Innovation at UN ESCAP. Earlier, she worked as a Professor of Economics at the Indian Institute of Management Bangalore and was an Economist at the IMF in Washington, DC. She holds a PhD from Columbia University and BA from Harvard University. Her research interests include the WTO, international trade in services, regional integration, health services, and migration. She has served on national and international committees and advisory boards in these areas and has undertaken research for several international organizations and think tanks, including the World Health Organization (WHO), United Nations Development Programme (UNDP), OECD, European Commission, World Bank and ICRIER. She has published extensively in the form of authored and edited books, journal articles, book chapters, reports, and popular media articles. She frequently presents in national and international forums.



## Professor Selim Raihan

Executive Director, SANEM, and Professor Dhaka University, Dhaka

Dr Selim Raihan is a Professor at the Department of Economics, University of Dhaka, Bangladesh and the Executive Director of the South Asian Network on Economic Modeling (SANEM). He holds a PhD from the University of Manchester, UK. Professor Raihan is the Honorary Senior Research Fellow at the University of Manchester, UK. He is an alumnus of Harvard University's program on "Cutting Edge of Development Thinking". He possesses vast expertise in empirical research on international trade, economic growth, poverty, labour market, macroeconomic policies, political economy, and climate change issues. He has worked quite extensively on applied economics, especially assessing impacts of trade and economic policies, using country-specific and global Computable General Equilibrium (CGE) models, and micro and macro-econometric modelling and estimation techniques. Professor Raihan is the editor of Thinking Aloud - a monthly digest from SANEM. He contributed extensively to the preparation of the Sixth and Seventh Five-year National Plans of Bangladesh. He led a research team to prepare the SDG Financing Strategy: Bangladesh Perspective - a flagship publication of the Planning Commission of Bangladesh. He has worked for several national and international organizations including the Asian Development Bank, the World Bank, UNDP, UNESCAP, UNCTAD, IFPRI, the Commonwealth Secretariat, FAO, European Commission, ILO, IDRC, DFID, etc.



## Dr Paras Kharel

Executive Director, South Asia Watch on Trade, Economics and Environment (SAWTEE), Kathmandu

Dr. Paras Kharel is an economist engaged in research, capacity building and policy advocacy on international trade and development. He has been with South Asia Watch on Trade, Economics and Environment (SAWTEE) – a Kathmandu-based think tank – since 2007 and is currently its Executive Director. He has a PhD in Economics (University of Melbourne) with specialization in international trade and applied microeconomics. Kharel's research and publications span regional integration, trade facilitation, gains from trade, application of structural gravity models, World Trade Organization issues, export competitiveness, aid for trade, linkages between trade policy and industrialization, structural transformation, sustainable development, development finance, economic reforms, SMEs, trade and development issues of least-developed and landlocked countries, and migration and remittances. His publications include two edited volumes on South Asian cooperation/integration, and articles in peer-reviewed journals such as Review of International Economics, International Economics, East Asian Economic Review and Review of Development Economics.



## Professor Amita Batra

Jawaharlal Nehru University (JNU), New Delhi

Dr. Amita Batra is a Professor, South Asian Studies, JNU. She has worked as Senior Fellow at the ICRIER, New Delhi for five years and before that as Reader, Economics, Hindu College, University of Delhi. ### **Dr. Arabinda Mitra**



**Distinguished Fellow and Former Scientific Secretary, Office of the Principal Scientific Advisor to Government of India, New Delhi**

Dr. Arabinda Mitra holds a PhD from University of Cambridge, U.K., and is an Earth Scientist by training with four decades of experience at the interface of research, education and innovation. Both as a scientist and as an able science administrator, he has held scientific positions in the Dept of Atomic Energy, Ministry of Earth Sciences and the Dept of Science & Technology, Government of India. At the National Centre for Polar & Ocean Research, Goa, he was responsible for formulating and implementing the scientific programs of the Indian Antarctic expedition and established the first low temperature ice-core research laboratory of the country. He has been a member of the Indian expedition to Antarctica and has undertaken research cruises to the Indian, Atlantic, Pacific and Southern Oceans. He has won several academic awards including Cambridge-Nehru Fellowship, ORS Award of UK; Bursary Award of St. Edmund's College UK; JSPS Bridge Award of Japan and was elected as a Fellow of the Geological Society, London. He has authored international publications in Nature, Marine Chemistry, Geochimica Cosmochimica Acta, International Journal of Remote Sensing, etc. In 2004, Dr. Mitra was appointed as the first Executive Director of the bi-national Indo-US Science and Technology Forum where he played a seminal role in enriching the scope and contents of Indo-American cooperation in Science, Technology and Innovation (STI) by linking academia, research laboratories and industry. In 2011, Dr. Mitra assumed the position of Adviser & Head International Cooperation in DST, where he oversaw India's research and innovation engagements with 44 countries across the globe. In 2018, he was appointed as the Scientific Secretary in the Office of the Principal Scientific Adviser with the mandate to develop national S&T missions, provide policy interventions, and render periodic advice across the Government in matters related to science, technology and innovation. Subsequently, as a Distinguished Fellow in the O/o PSA he was involved in developing capacity building plans for scientists and technologists of seven S&T Departments of Government of India. He

has served on numerous Governing Boards/Councils of research institutions and industry bodies. From Nov 2022 until Jan 2025, he served as Advisor in the Startup Incubation and Innovation Centre of IIT-Kanpur. Currently he is serving as Advisor with the Foundation for Innovation and Technology Transfer at IIT-Delhi supporting deep-tech startup eco-system across sectoral domains. He also serves as Consultant with the Wadhwani Foundation working with top academic institutions to support translational research aimed towards technology-led product development and promoting startup enterprises.



### **Professor Rajat Kathuria**

**Dean, School of Humanities and Social Sciences, Shiv Nadar University, New Delhi**

Professor Rajat Kathuria carries over 20 years of experience in teaching and more than 15 years of experience in economic policy, besides pursuing extensive research on a range of issues relating to regulation and competition policy while working with ILO and UNCTAD. 


### **Ambassador Sumith Nakandala**

A former Vice-Chancellor of the University of Jammu—appointed at the youngest age in independent India—he has bridged academia and public policy through roles including Cabinet-rank Advisor to the Chief Minister of Jammu and Kashmir, member of the National Security Council advisory board, and member of the National Knowledge Commission. He founded the Australia India Institute and co-chaired the Australia India Leadership Dialogue, and chaired a long-running Track II dialogue between India and Pakistan. A D.Phil. from Oxford, he has held visiting professorships at Stanford, Notre Dame, Illinois Urbana-Champaign, and Paris. He has published 12 books and 50+ articles, supervised numerous doctoral and M.Phil. theses, and received the Padma Shri and an honorary Doctor of Laws.



### **Mr. Uttam Kumar Shahi**

**Director, BIMSTEC, Dhaka**

Mr. Uttam Kumar Shahi, a career diplomat from Nepal Foreign Service, joined the Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC) Secretariat as a Director on 16 March 2025. He is the third Director from Nepal serving at the Secretariat. Prior to this, Mr. Shahi served at the Foreign Ministry under different capacities such as Undersecretary at the Office of the Foreign Minister, Deputy Chief of Protocol and Undersecretary at the International Relations Division, Office of the President of Nepal. # Concept Note



The Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC) was set up in 1997 to foster economic and social development among member countries, namely, Bangladesh, Bhutan, India, Myanmar, Nepal, Sri Lanka and Thailand. Its significance lies in the fact that it serves as the bridge between the South Asian and Southeast Asian countries through intra-regional collaboration in seven priority areas. BIMSTEC opens up opportunities for the South Asian region as a viable alternative for regional cooperation.

BIMSTEC started its journey in 1997 in Bangkok, where the four countries of the Bay of Bengal region, namely, Bangladesh, India Sri Lanka and Thailand convened a meeting and jointly formed a new sub-group on 6 June 1997 by the name BIST-EC (Bangladesh, India, Sri Lanka, Thailand – Economic Cooperation). Myanmar attended this summit as an observer and obtained full membership in December that year. To acknowledge the additional membership, the acronym was changed to BIMSTEC. Subsequently, Nepal and Bhutan also joined in 2004. In the first Summit of Heads of Governments held on 31 July 2004, the leaders of the group formally announced the complete name of the grouping as the Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation, in short BIMSTEC. In 2011, a permanent secretariat was established in Dhaka. At the highest level, six BIMSTEC Summits have been held so far; one in 2004, held in Bangkok, 2008 in Delhi, then in 2014 at Nay Pyi Taw, 2018 in Kathmandu, 2022 in Colombo, and 2025 in Bangkok. India hosted the BRICS-BIMSTEC Outreach meeting at Goa in October 2016.

Recently, BIMSTEC has reorganised its priority areas into seven including (i) Trade, Investment and Development, (ii) Environment and Climate Change, (iii) Security, (iv) Agriculture and Food Security, (v) People-to-People Contact, (vi) Science, Technology and Innovation and (vii) Connectivity. Moreover, the BIMSTEC Charter was signed and adopted during the Fifth BIMSTEC Summit, which was held in virtual format in Colombo in 2022.

The world is passing through a turbulent time with high trade uncertainties and control, geopolitical risks, supply chain disruptions, natural disasters, etc. Global uncertainties are looming large. Multilateralism is under threat. Smaller landlocked and island economies are most vulnerable and facing disproportionate threats. In times of global uncertainty, the BIMSTEC comprising Bangladesh, Bhutan, India, Myanmar, Nepal, Sri Lanka and Thailand faces a complex mix of escalating geopolitical rivalries, severe climate change impacts, and fragmented economic conditions. The region's coastlines and dense populations are acutely vulnerable to intensifying environmental disasters. On the other hand, global economic uncertainties have also underscored the need for deeper regional integration. The role of the Global South is critical to any transformative change in global governance and regional cooperation frameworks.

BIMSTEC has unique resource endowments and geographic location that can be leveraged effectively for promoting connectivity, trade and investment and people-to-people contacts among the South Asian and Southeast Asian countries. Further, these littoral states of the Bay of Bengal also connect major international maritime trade routes between the Indian Ocean and the Pacific Ocean. Further, BIMSTEC member states are a powerhouse in a number of products such as garments (Bangladesh), digital services (India), maritime services (Sri Lanka), consumer durables (Thailand), tourism (Nepal and Bhutan), among others. Greater intra- and inter-regional cooperation may pave the way for higher trade and growth among the BIMSTEC countries. Moreover, deeper regional understanding on global challenges and collective endeavour can provide sustainable solutions.

In view of the above, Research and Information System for Developing Countries (RIS) in collaboration with the think-tanks of the Bay of Bengal region, the BIMSTEC Secretariat, the International Development Research Centre (IDRC), and the UNESCAP SSWA is organising the fourth Bay of Bengal Economic Dialogue (BoBED) in New Delhi on 16-17 January 2026 on the theme 'Towards a Prosperous Bay of Bengal amidst Global Uncertainties'. The current network partners of the BoBED are SANEM (Bangladesh), RIS (India), SAWTEE (Nepal), Pathfinder Foundation (Sri Lanka), and Chulalongkorn University (Thailand). Originated at the SANEM, the previous three editions of the BoBED were held in Dhaka (2021, 2022) and Bangkok (2024), respectively. The Delhi BoBED edition will be attended by senior experts, research scholars, diplomats, and practitioners from the Bay of Bengal region. The Secretary General and other senior officials of BIMSTEC Secretariat will be joining the programme. Partner organizations such as the ADB, the UNESCAP, the World Bank, etc. have also agreed to extend their support in organising the Dialogue.

The conference has six technical sessions covering all major areas of BIMSTEC cooperation. Besides deliberations in the conference, the organizers will issue the *Delhi Declaration* presenting the key outcomes of the Dialogue. Suitable publication opportunities will be worked out post-event.

## Session I: Reimagining Global South and the Role of the Bay of Bengal

---

Shaping a Global South agenda towards enhanced cooperation and integration is vital amid escalating conflicts, climate change and more frequent extreme weather, resource depletion, and supply chain disruptions driven by unilateral trade measures such as rising tariffs and the CBAM. These shocks, alongside persistent poverty, hunger, and low land and labour productivity, are widening socioeconomic divergence across Global South countries. In this context, deeper integration and cooperation—particularly among the Bay of Bengal nations—can address historical and structural backwardness. Establishing shared mechanisms and a common framework to pursue inclusive development is indispensable to meet collective aspirations and deliver the 2030 Agenda and its SDGs. This session, therefore, aims to address some of the following issues:

- Fostering Global South Integration: How does the Bay of Bengal reshape the Global South agenda under the global uncertainty to meet their shared development aspiration?
- Integration Mechanisms: What concrete institutional mechanisms and common frameworks are needed among Bay of Bengal states to overcome historical and structural backwardness?
- Supply Chain Resilience: What collective strategies can mitigate supply chain disruptions caused by unilateral trade measures (e.g., tariffs, CBAM) while safeguarding development objectives?
- Poverty and Productivity: How can regional cooperation address persistent poverty, hunger, and deprived land and labor productivity to overcome structural backwardness?
- Adaptation Priorities: How should Bay of Bengal nations prioritize regional adaptation to reduce the negative impact of systemic issues including geo-political tensions, climate change, and more frequent extreme weather to protect vulnerable countries and populations?
- Explore the effective ways and instruments to enhance regional financing for funding resilience and shared development goals?
- How can deeper integration be designed to accelerate inclusive development and ensure the Bay of Bengal region meets the 2030 Agenda and its SDGs?

---

## Session II: Trade, Investment, and Regional Value Chains: Deepening Regional Integration amidst Global Uncertainties

---

Equitable, inclusive, sustainable, and resilient trading systems are essential to achieve the global developmental agenda, particularly Global South countries' aspirations are closely associated and significantly influenced by it. Therefore, ensuring the efficient multilateral and regional trading system is vital to reducing poverty, ensuring global food security along with boosting employment, investments and economic growth. Trade is also critical to achieving the 2030 Agenda by fostering growth and higher per capita income. Evidence shows deeper regional integration is a strategic priority amid global uncertainties. Policies and trade agreements that lower tariff and non-tariff barriers, deepen regional value chains, and attract investment can expand market access, boost competitiveness, and enhance comparative advantage. Advancing regional integration among the Global South countries in particular across the Bay of Bengal region (comprising Bangladesh, Bhutan, India, Myanmar, Nepal, Sri Lanka and Thailand) is essential to enhance trade and increase cross-border investments. This will also advance economic cooperation among the member states. In this regard, promoting the actionable interventions is necessary to improve regional cooperation and integration and to achieve the BIMSTEC Bangkok Vision 2030 to build a Prosperous, Resilient, and Open BIMSTEC by 2030. In this context, this session aims to explore possible solutions to some of the following questions and produce actionable policy recommendations.

- Explore to promote the actionable interventions by BIMSTEC members to deepen regional cooperation and integration towards strengthening resilient supply chains, and attract investment and to reducing tariff and non-tariff barriers?
- What actions can be taken to enhance trade facilitation and its measures should be harmonised to reduce border delays and logistics costs across the Bay of Bengal?
- How does FTAs deepen regional value chain including enhancing Trade and Investments?

---

### **Session III: Economic Corridors and Multi-Modal Connectivity: Integrating the Bay and Beyond**

---

Economic corridors play a key role in integrating economies across region. Some of their environmental effects notwithstanding, well-functioning and efficient economic corridors are essential for the development of a region. Economic corridors are meant to serve as a blueprint for enhanced connectivity, increased competitiveness, and a greater sense of community in the Bay of Bengal region. Economic corridors also help strengthen industrial (or, services) agglomeration over time through establishment of industrial zones (or, SEZ) and also help in dispersion from congested or agglomerated zones to less congested or in periphery areas. Climate-friendly economic corridors are essential to promote sustainable connectivity. The Bay of Bengal region has witnessed some good progress in maritime and border connectivity, whereas the progress in land and digital connectivity is limited and they are yet to acquire the needed momentum for deepening the integration. BIMSTEC member states have signed the Maritime Cooperation Agreement (MCA) at the 6<sup>th</sup> BIMSTEC Summit. BIMSTEC member states have taken up trade facilitation initiatives including paperless trade measures. However, the economic corridor alone cannot be successful until and unless other operational priorities such as trade policy, trade facilitation and transit, institutions, energy corridors, telecommunications, etc. are in place. Therefore, a strategic partnership for policy development to set-up an economic corridor and an action plan to foster regional cooperation and integration have to be implemented in the region. In general, the task ahead is to revive the transportation networks in the Bay of Bengal region and beyond, and establish region-wide multimodal transport and transit to reduce transportation costs. In view of the above, this session aims to review the progress in multi-modal connectivity in the Bay of Bengal region. It will also discuss the challenges and possible mitigation measures, and provide answers to following questions:

- What are the shared challenges in connectivity in the Bay of Bengal? What can be done in mitigating such challenges in order to strengthen the connectivity?
- What are the policy reform gaps in promoting regional infrastructure such as the economic corridor in the Bay of Bengal?
- What should be done in facilitating economic corridors in the Bay of Bengal region? Are there any lessons that India can offer?

---

## **Session IV: Climate Change, Sustainable Development and Blue Economy: Towards a Resilient Bay of Bengal**

---

The changing climate with an increased frequency of extreme climatic conditions are weakening the growth momentum besides unsuitable livelihoods, increased hunger, food insecurity, malnutrition, damaging physical and connectivity infrastructure. Such adverse impact is more evident across all the sectors and regions globally. Particularly, the Bay of Bengal region is more vulnerable to the extreme climatic conditions with an increased frequent natural disaster such as floods, cyclones and earthquakes, etc. This necessitates ensuring resilience and sustainability is necessary by increased cooperation and collaborations towards enhancing the adaptation and mitigation strategies to safeguard against climate change future shocks. Such interventions need to be promoted across the sector by prioritising the climate sensitive sectors as well. This will help in achieving the shared socioeconomic development prospects of the regions while saving lives and livestock further. In this regard, deepening regional cooperation among the member countries includes sharing climate-smart technologies and innovations, dedicated climate finance and related R&D investments to support effective implementation of adaptation activities, along with knowledge sharing and the promotion of nature-based solutions. This session aims to address some of the following questions:

- Explore the strategic ways to deepening cooperation and collaborations towards ensuring climate resilient and sustainability of the Bay of Bengal region under changing climate and frequent extreme climatic condition includes natural disasters
- How can Bay of Bengal countries prioritize and finance for climate-smart technologies and R&D to accelerate adaptation in the most climate-sensitive sectors?
- How can blue-economy strategies be aligned with sustainable development goals to balance economic growth, ecosystem health, and climate resilience in the region?
- What institutional arrangements and capacity-building programmes are required to improve cross-border knowledge sharing and joint implementation of adaptation projects?
- Which nature-based solutions offer the highest cost-effectiveness and co-benefits for disaster risk reduction, food security, and livelihoods in the Bay of Bengal?
- How can member states harmonize policies and share best practices to strengthen infrastructure resilience and protect connectivity networks from extreme events?

---

## **Session V: AI Governance and Digital Integration: Enabling Integration, Key Challenges and Solutions**

---

The rapid diffusion of artificial intelligence (AI) is reshaping economies, societies and governance systems, intensifying the need for an inclusive AI governance framework that supports inclusive digital integration. This session intends to examine the intersection of AI governance and digital integration with a specific focus on the BIMSTEC region. It would discuss the prevailing AI governance and regulatory architecture, along with the digital strategy across the BIMSTEC member states. At the same time there are key governance challenges including data sovereignty, algorithmic accountability, cyber-security, and uneven digital capacities across the region. This scenario highlights the role of regional cooperation mechanisms, interoperable digital public infrastructure, and multi-stakeholder engagement. Strengthening capacity-building, aligning regulatory approaches, and fostering public-private collaboration can emerge as key pathways to achieving resilient and equitable digital integration in an AI-driven world. Given this, there is an imperative for a coordinated, context-sensitive AI governance framework, aligned with BIMSTEC's development priorities, which is essential for building a resilient, inclusive, and future-ready digitally integrated regional economy. In light of this, this session aims to discuss the following:

- What is the current state of AI governance and regulatory architecture across BIMSTEC member states and how are they striving for enhancing digital integration?
- What lessons can the BIMSTEC Members States learn from each other toward responsible development of AI and inclusive digital integration?
- What is the role of cooperation in addressing uneven digital capacities and risk of digital exclusion, since the disparities in infrastructure, skills, and institutional readiness may limit inclusive participation of countries in AI-driven digital integration?

---

## Session VI: Accelerating Regional Integration in the Bay of Bengal: Role of People-to-People Contacts

---

Bay of Bengal countries share deep cultural bonds. Connected by common heritage and civilization, BIMSTEC has made good progress in the area of people-to-people contacts. In BIMSTEC, the people-to-people sectoral cooperation consists of four sub-sectors: culture, tourism, people-to-people contact forums and poverty alleviation. There are initiatives to create forums for media and parliamentarians to enhance dialogue. India hosted the BIMSTEC Aquatics Championship in New Delhi in 2024 with 400-plus athletes from all BIMSTEC member states; India organized the BIMSTEC Youth Summit in Ahmedabad in February 2025; a special 'BIMSTEC Pavilion' was established at the 38th Surajkund International Crafts Fair in February 2025; BIMSTEC Youth Led Conference on Climate Change organized in February 2025 in New Delhi. BIMSTEC member states have agreed to take concrete steps to promote intra-BIMSTEC tourism, including through cross-border travel facilitation and sustainable tourism practices, leveraging the region's rich natural, cultural heritage, and historical sites, which can help boost economic growth and employment. Promoting travel and cultural exchanges is going to build cultural bonds. The network of think-tanks and universities are important means to strengthen cultural contacts. BIMSTEC underscores the critical importance to build on the progress made with regard to BIMSTEC tourism circuits, including the BIMSTEC Buddhist Circuits, BIMSTEC Temple Circuits, and BIMSTEC Eco-Tourism Circuits. Greater public-private partnership is required to enhance infrastructure, services, and innovation in the tourism sector. There are immense opportunities in education, media, travel and tourism, health, etc. in the Bay of Bengal region. There have been discussions on BIMSTEC Visa Schemes (exemption/ simplification) to ease travel. In view of the above, this session aims to take a stock of progress made in the area of people-to-people contacts and discuss the new agenda for accelerating regional integration. This session, in particular, aims to answer to following questions:

- What should be done to build a truly "people-oriented, people-centered" cultural community in the Bay of Bengal region?
- What would be the strategy to leverage shared history, culture, and civilizational links for deeper strategic partnerships in the changing global order?
- What can be done to deepen the cross-regional cultural contacts?



RIS specialises in issues related to international economic development, trade, investment and technology. It is envisioned as a forum for fostering effective policy dialogue and capacity-building among developing countries on global and regional economic issues. The focus of the work programme of RIS is to promote South-South Cooperation and collaborate with developing countries in multilateral negotiations in various forums. Through its following centres/ forums, RIS promotes policy dialogue and coherence on regional and international economic issues.



The word "DAKSHIN" (दक्षिण) is of Sanskrit origin, meaning "South." The Hon'ble Prime Minister of India, Shri Narendra Modi, inaugurated DAKSHIN - Global South Centre of Excellence in November 2023. The initiative was inspired by the deliberations of Global South leaders during the Voice of the Global South Summits. DAKSHIN stands for Development and Knowledge Sharing Initiative. Hosted at the RIS, DAKSHIN has established linkages with leading think tanks and universities across the Global South and is building a dynamic network of scholars working on Global South issues.



AIC at RIS has been working to strengthen India's strategic partnership with ASEAN in its realisation of the ASEAN Community. AIC at RIS undertakes research, policy advocacy and regular networking activities with relevant organisations and think-tanks in India and ASEAN countries, with the aim of providing policy inputs, up-to-date information, data resources and sustained interaction, for strengthening ASEAN-India partnership.



CMEC has been established at RIS under the aegis of the Ministry of Ports, Shipping and Waterways (MoPS&W), Government of India. CMEC is a collaboration between RIS and Indian Ports Association (IPA). It has been mandated to act as an advisory/technological arm of MoPSW to provide the analytical support on policies and their implementation.



FITM is a joint initiative by the Ministry of Ayush and RIS. It has been established with the objective of undertaking policy research on economy, intellectual property rights (IPRs) trade, sustainability and international cooperation in traditional medicines. FITM provides analytical support to the Ministry of Ayush on policy and strategy responses on emerging national and global developments.



BEF aims to serve as a dedicated platform for fostering dialogue on promoting the concept in the Indian Ocean and other regions. The forum focuses on conducting studies on the potential, prospects and challenges of blue economy; providing regular inputs to practitioners in the government and the private sectors; and promoting advocacy for its smooth adoption in national economic policies.



FIDC, has been engaged in exploring nuances of India's development cooperation programme, keeping in view the wider perspective of South-South Cooperation in the backdrop of international development cooperation scenario. It is a tripartite initiative of the Development Partnership Administration (DPA) of the Ministry of External Affairs, Government of India, academia and civil society organisations.



FISD aims to harness the full potential and synergy between science and technology, diplomacy, foreign policy and development cooperation in order to meet India's development and security needs. It is also engaged in strengthening India's engagement with the international system and on key global issues involving science and technology.



As part of its work programme, RIS has been deeply involved in strengthening economic integration in the South Asia region. In this context, the role of the South Asia Centre for Policy Studies (SACEPS) is very important. SACEPS is a network organisation engaged in addressing regional issues of common concerns in South Asia.



Knowledge generated endogenously among the Southern partners can help in consolidation of stronger common issues at different global policy fora. The purpose of NeST is to provide a global platform for Southern Think-Tanks for collaboratively generating, systematising, consolidating and sharing knowledge on South South Cooperation approaches for international development.



DST-Satellite Centre for Policy Research on STI Diplomacy at RIS aims to advance policy research at the intersection of science, technology, innovation (STI) and diplomacy, in alignment with India's developmental priorities and foreign policy objectives.
