Shri Mangubhai Patel

Hon'ble Governor of Madhya Pradesh

Shri Mangubhai Chhaganbhai Patel is an Indian statesman who is the current and 19th Governor of Madhya Pradesh. He is a leader of Bharatiya Janata Party from Gujarat. He served as the officiating speaker of the Gujarat Legislative Assembly in 2014. He has earlier served as a cabinet minister in the Government of Gujarat.



Shri Shivraj Singh Chauhan

Hon'ble Chief Minister, Madhya Pradesh

Shri Shivraj Singh Chouhan is an Indian politician and member of the Bharatiya Janata Party. He is the 17th and current Chief Minister of Madhya Pradesh, having been elected to the same position 3 times in the past, and a Member of Legislative Assembly in Madhya Pradesh from Budhni.



Shri Suman Bery

Vice Chairperson, NITI Aayog, Government of India

Shri Suman Bery is currently Vice Chairperson, NITI Aayog, in the rank and status of a Cabinet Minister. An experienced policy economist and research administrator, Mr Bery took over as NITI Aayog Vice Chairperson from 1st May 2022. His recent affiliations include Senior Visiting Fellow at the Centre for Policy Research, New Delhi; non-resident fellow at Bruegel, Brussels; and Global

Fellow at the Woodrow Wilson Center, Washington DC. He has also served on the Board of the Shakti Sustainable Energy Foundation, New Delhi. From early 2012 till mid-2016, Mr Bery was Royal Dutch Shell's global Chief Economist based in The Hague. In this capacity, he advised the board and management on global economic and political developments. He was also part of the senior leadership of Shell's global scenarios group. During his time at Shell, he led a collaborative project with Indian think tanks (later published) to apply scenario modeling to India's energy sector. Mr Bery has previously served as Director General (Chief Executive) of the National Council of Applied Economic Research (NCAER) and the global Chief Economist of Royal Dutch Shell. He was also a member of the Prime Minister's Economic Advisory Council, Statistical Commission and the Reserve Bank of India's Technical Advisory Committee on Monetary Policy. Prior to NCAER, Mr Bery was with the World Bank in Washington DC and his areas included macroeconomy, financial markets and public debt management with a focus on Latin America. His professional writing includes contributions on the political economy of reform, financial sector and banking reform, and energy trends and policy. He has a master's degree in public affairs from Princeton University's School of Public and International Affairs, and an undergraduate degree in philosophy, politics and economics from Magdalen College, University of Oxford.



Shri Harsh Vardhan Shringla

G-20 Chief Coordinator, Government of India

Harsh Vardhan Shringla is Chief Coordinator for India's G20 Presidency in 2023. He has previously served as Foreign Secretary of India, Ambassador to USA, High Commissioner to Bangladesh and Ambassador to Thailand. Ambassador Shringla joined the IFS in 1984 and in the course of a diplomatic career spanning over 35 years; he held a variety of positions in the Ministry of External Affairs (India), New Delhi and abroad besides becoming India's Ambassador/High Commissioner to the USA, Bangladesh and Thailand. Abroad, he served in different Missions of India in France (UNESCO); Permanent Mission to the United Nations in New York; Vietnam (Hanoi and Ho Chi Minh City); Israel and South Africa (Durban). He also served as a Foreign Secretary, Government of India. Harsh Vardhan Shringla graduated from the St. Stephen's College, Delhi University after being schooled at Mayo College, Ajmer. He worked in the private and public sectors in India prior to joining the Indian Foreign Service. He has published papers on conflict prevention, economic diplomacy, the Indian diaspora, and India-Bangladesh relations.



Professor Sachin Chaturvedi

Director General, RIS and Vice Chairman, AIGGPA and Madhya Pradesh Rajya NITI Aayog

Professor Sachin Chaturvedi is currently Director General at the Research and Information System for Developing Countries (RIS), a New Delhi-based Think-Tank. He works on issues related to development economics, involving development finance, SDGs and South-South Cooperation, apart from trade, investment and innovation linkages with special focus on WTO. Currently, he is also Vice Chairman, Atal Bihari Vajpayee Institute of Good Governance and Policy Analysis; and ex-officio Vice Chairman of Madhya Pradesh State Policy and Planning Commission. He is also Member, Board of Governors, Reserve Bank of India. Professor Sachin Chaturvedi was also the 'Global Justice Fellow' at the MacMillan Center for International Affairs at Yale University (2009-2010) and has served as a Visiting Professor at the Jawaharlal Nehru University (JNU) and was a Developing Country Fellow at the University of Amsterdam (1996), Visiting Fellow at the Institute of Advanced Studies, Shimla (2003), and Visiting Scholar at the German Development Institute (2007). He has authored/edited more than 22 books, apart from contributing several chapters in the edited volumes and also publishing several research articles in prestigious journals. He is on the Editorial Board of several journals including the South Asian Economic Journal, IDS Bulletin, Sussex, UK among others. His book "The Logic of Sharing - Indian Approach to South-South Cooperation" has been acclaimed internationally as one of the best volumes on international development cooperation. He is credited with the launch of Network of Southern Think Tanks (NeST) and Forum for Indian Development Cooperation (FIDC). He has also created "Delhi Process", a major forum for exchange of ideas on South-South Cooperation.



Ambassador Sujan R. Chinoy

T20 Chair & Director General, MP-IDSA, New Delhi

Sujan R. Chinoy is a former Indian diplomat and currently serving as the Director General of the Manohar Parrikar Institute for Defence Studies and Analyses (MP-IDSA), India's foremost think-tank in New Delhi in the field of defence, security and international relations since 3rd January 2019. He is Chair of Think-20 for G20 India Presidency. He spent more than thirty-seven years as a professional diplomatic career spanning with experience on China and East Asia, as well as the Asia-Pacific region, the Gulf and OIC, United Nations (Disarmament and International Security), National Security, as well as the US and the Latin American region. He held the highest rank of Grade I Ambassador (equivalent to Vice Minister/Secretary to the Government of India). He was Indian Ambassador to Japan from 2015-2018. He was also the Indian Ambassador to the Republic of the Marshall Islands. He facilitated the visits of Prime Minister Narendra Modi to Japan in 2016 and 2018 as well as Prime Minister Shinzo Abe's visits to India in 2015 and 2017. He also served as India's representative to the First Committee at the United Nations in New

York dealing with Disarmament & International Security Affairs and in the Indian Mission in Riyadh. At Headquarters, in the Ministry of External Affairs, he served as Director (China) as well as Head of the Expert Group of Diplomatic & Military Officials tasked with CBMs and boundary-related issues with China. He also served on the Americas Desk dealing with the USA and Canada, and as Officer on Special Duty in charge of press relations in the External Publicity Division.



Mr George Laryea-Adjei

Regional Director for South Asia, UNICEF, Nepal

Mr. George Laryea-Adjei is the UNICEF Regional Director for South Asia, based in Kathmandu, Nepal. He is in charge of leadership, oversight and guidance to the eight UNICEF country programmes: Afghanistan, Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan and Sri Lanka. He also represents UNICEF with governments, donors, the private sector and civil society in the region. With over 21 years of service in UNICEF, he has profound expertise in policy formulation and strategic planning, evaluation, crisis management, systems strengthening, resource mobilisation and partnerships. Before his current assignment, he was the Director of Evaluation in UNICEF New York. He has also served as Deputy Director for UNICEF, Deputy Representative and Chief of Social Policy for UNICEF South Africa, Strategic Planning Office for UNICEF New York, and Programme Officer for UNICEF Ghana. A national of the Republic of Ghana, he is an economist by profession. He holds a bachelor's degree in Development Planning from the University of Science & Technology, Ghana, and a Master's Degree in Urban Management and PhD in Economics from Erasmus University, The Netherlands.



Mr Tetsushi Sonobe

Dean and CEO, ADBI, Tokyo, Japan

Tetsushi Sonobe is the Dean and CEO of the Asian Development Bank Institute (ADBI), the Tokyo-based think tank of the Asian Development Bank that promotes the realization of a prosperous, inclusive, resilient, and sustainable Asia and the Pacific through policy research and capacity building. Dean Sonobe obtained his PhD in economics from Yale University and BA in economics from the University of Tokyo. His research interests are centered on the empirics of economic development, particularly the roles of industrial clusters, human capital, social capital, management practices, and market competition in industrial development in developing Asia and other regions. Dean Sonobe is a recipient of the Nikkei Book Publication Prize and the Masayoshi Ohira Memorial Prize, and a founding board member of the Japanese Association for Development Economics.

He was the Commissioner and Secretary, Home and Political and State Coordinator to update the National Register of Citizens (NRC) of 1951 for the state of Assam. He has earlier held the position of Mission Director, National Rural Health Mission; Commissioner and Secretary, Health and Family Welfare. He has also served as the Deputy Commissioner of Kamrup Metropolitan, Goalpara and Nagaon.

Special Envoy of Climate Vulnerable Forum (CVF) Presidency of Bangladesh and a Commissioner of Global Commission on Biodiver Cities by 2030

Mr. Abul Kalam Azad is Special Envoy of the Climate Vulnerable Forum (CVF) Presidency where he represents H. E. Sheikh Hasina, Hon. Prime Minister of Bangladesh, the CVF Chair. Earlier to this, Mr. Azad coordinated all administrative, development and reform process from Prime Minister's Office as Principal Secretary to the Honourable Prime Minister of Bangladesh and as Secretary. For the last four years he has been supporting and guiding the implementation of 100 Economic Zones, development of investment and business climate and also worked as Principal SDG Coordinator for the national coordination of Bangladesh's efforts towards the Sustainable Development Goals, based in the Bangladesh Prime Minister's Office. Special Envoy Azad also served as secretary of the Power Division of the Government of Bangladesh, where his efforts helped to increase Bangladesh's power generation capacity by three times, expand energy access and develop one of the world's largest renewable energy projects which has resulted in millions of low-income households across the country benefiting from renewable power.

She has experienced Team Lead responsible for some of the largest Development Pathways assignments in the high-level design

of social protection schemes and operational support, policy advice and social protection strategy drafting, and coordinating the training portfolio. Dr. Chaturvedi was named in the Federal 100 by Federal Computer Week and received the "Sagamore of the Wabash" Award from the Governor of Indiana, the highest civilian award for his service to the state.



Shri Amar Sinha

Former Secretary, Economic Relations, Ministry of External Affairs, India; Distinguished Fellow, RIS

Mr. Amar Sinha retired from the Indian Foreign Service (IFS) as Secretary, Economic Relations in the Ministry of External Affairs, New Delhi, in June 2017 after a diplomatic career spanning 35 years. He has served in different capacities in Indian Mission around the world including in Algiers (1983-87), Buenos Aires (1987-90), Washington DC (1998-2001) Jakarta (2001-04), and Brussels (2004-07). In 2007 he was appointed India's Ambassador to Tajikistan (2007-2010) and on his return to New Delhi served as Joint Secretary Trade Policy in the Ministry of Commerce and Industry (2010-13) where he handled the WTO and other trade negotiations. He also oversaw India's participation in various multilateral for a such as UNCTAD, APTA, BIMSTEC, G20, IBSA, BRICS, etc. In 2013 he was appointed India's Ambassador to Afghanistan (2013-2016), after completion of his assignment in Kabul successfully he assumed the charge of the post of Secretary (Economic Relations) in the Ministry of External Affairs, New Delhi, on January 15, 2016. At present he is a Distinguished Fellow at RIS since November 2017 and has lent support to several think tanks focused on Afghanistan and other strategic issues. He is also currently a Member of the National Security Advisory Board (NSAB).

This was followed by Schwab Foundation Award for Outstanding Social Entrepreneur in 2004; Officer of the Order of the British Empire (OBE) in 2008 and Duke of Edinburgh Conservation Medal at Buckingham Palace (2011) in recognition for his outstanding, life-long service to the environment.

Dr. Beena Pandey works as a Assistant Professor, at RIS, New Delhi. Her research areas broadly cover social sector issues like quality of education, gender empowerment and development issues. Dr Bhavana Prasher is a Principal Scientist in CSIR-IGIB and Professor in AcSIR. Dr. Bhavana Prasher has pioneered in the establishment of the new field of Ayurgenomics that aims to integrate principles of Ayurveda with genomics for personalized and preventive medicine since its inception in 2002. Her group has for the first time provided molecular and genomic basis to the principles of Prakriti and using ML based approaches recapitulated the basis of Prakriti assessment. These have propelled biomarker discoveries which have enabled its global acceptance.



Dr Biswajit Roy Chowdhury

South Asian Institute for Advanced Research & Development

Dr Biswajit Roy Chaudhury is the Founder Chairperson of South Asian Institute for Advanced Research and Development (SAIARD) and Founder Chairperson of International Institute of Geospatial Science and Technology (IIGST). He is also Lecturer in Geography in Vidyasagar College, Kolkata, West Bengal. The SAIARD is a premier research institution, has been formed in Kolkata with a motto to spread the arena of research throughout the world particularly focusing on the major issues of the South Asian region.
